About us

Information we collect about you

We collect and process the following information about you:

- Information you provide to us. You can provide us with information about you by filling in

- **Information we collect about you.** When you use our website, we automatically collect information about you, your computer or mobile device, your IP address and information about how you use our website and other websites.
- Information we receive from other sources. We may receive information about you if you use a property portal website to contact us. How we use your personal information
